AGGRESSIVELY PURSUED AVAILABLE COVID FUNDING TO PROVIDE COMMUNITY-BASED INDIVIDUALS WITH DISABILITIES THE INFORMATION, PPE, AND ASSISTANCE THAT MIGHT BE NEEDED DUE TO ANY MOBILITY RESTRICTIONS THAT THEY MAY HAVE HAD BECAUSE OF THE PANDEMIC AND LACK OF COMMUNITY SUPPORTS. THE AGENCY PROVIDES OVER 2000 TRIPS DISSEMINATING COVID RELIEF KITS TO HUNDREDS OF PEOPLE WITH DISABILITIES IN THEIR SERVICE AREA.
