


TAKING CONTROL

Consumer Directed Personal Care

Taking Control is a unique program that can allow eligible Medicaid recipients to remain independent in their own home with the assistance of a Personal Care Aide (PCA). Assistance with daily living activities can be key to being self-sufficient and remaining in one's community. The person in the home becomes the employer of their PCA; hiring who they wish, including a relative. Our Staff can help with finding a PCA if needed, then ILGR will take care of the PCA's payroll and all of the Dept. of Labor aspects of employment. The service is paid for by Medicaid and allows a person to be "Taking Control" of their own care; hence Independent Living has labeled their program as such. WHY ART PARTNERING FOR THE DISABLED? Art is for everyone irrespective of disability! Art promotes learning, inspires connection, and enhances personal identity. As a conduit for artistic expression, ARTiculations Ability Exhibitions promote the inclusion of artists and audiences with disabilities into the rich network of exhibitions offered throughout Western New York.

Program

UHAA. The University Heights Arts Association (UHAA), organized in North Buffalo, is a group of artists that serves as a driving creative force and educational resource through the arts that make a positive difference in people's lives in each of several areas where they serve.

EXHIBITION PROGRAM. A part of the UHAA Art Partnering Program which places art in businesses and community spaces, ARTiculations Ability Exhibitions displays art by artists who are disabled at ILGR through quarterly solo and group exhibitions.

ELIGIBILITY. This program is open exclusively to artists who are disabled living in Genesee, Wyoming and Orleans counties.

MEDIUM. Photography, painting, illustration, collage, and mixed media

SIZE: May not exceed 30 in. wide x 36 in. high including the frame.

JURYING. Artists wishing to be considered for an exhibition must email photographs of at least three different artworks to: fineart@uhartsgroup.com..

PRESENTATION: All work must be framed and ready to hang. Either D rings or a "screw eye" may be used. No eye hooks. No "easel-back" photo frames.

DROP OFF/PICK UP: A time will be scheduled with the artist to drop off the work to be exhibited and to retrieve it after the exhibition closes.

RECEPTION: An annual reception at ILGR will celebrate all of the ARTiculations Ability Exhibitions held that year.

FEES/SALES: Neither the UHAA nor ILGR charge the artist to participate in an exhibition. All proceeds from the sale of any work are payable to the artist at the end of the exhibition. Artists are *not* required to sell their work in order
