So FE-ABD or the facilitated enrollment for the age blind and disabled helps people, it helps consumers or people apply for Medicaid.

We help them review whether Medicaid is the right option for them, discuss how it works, and even help them apply if they are interested.

All right.

And, I guess the program is geared towards just about anyone that might need Medicaid.

Yeah, but this program specifically focuses on people who are aged, meaning 65 and over, certified blind, and/or certified disabled.

Medicaid, which is a public health insurance program, is determined based off of finances, usually monthly income and resources.

Although those limits seem to be, although the limits may seem to be low,

may seem to be low and people might be higher, don't be discouraged about not applying for Medicaid as there might be options for you still and there's ways to get people onto Medicaid.

And, it actually enhances your medical coverage, such as if you're on Medicare or any other supplemental insurance.

How is eligibility determined for FE-ABD?

Like I said, it's determined based off of their monthly income, your monthly income and your resources.

They look at your financial situation.

And, then from there, the public health benefit will, the program helps, you know, will determine whether people are

All right, can you talk a little bit about the consumer's journey to enrollment and how the facilitated enrollment enroller helps to guide that journey?

Yeah, so applying for Medicaid is a journey, Ernie.

So let me give you a scenario.

Let's say the goal is to help someone apply for Medicaid to get, to have Medicaid take care of someone in your own home.

You know, someone who's a family member or a friend.

Starts with applying and then it takes some time for that process.

Eventually it leads to other determinations, other assessments, other eligibility requirements beyond the application.

And, we as the facilitated enrollers are kind of the first step in that journey.

So, we can help you and guide you through the Medicaid application process in the beginning and then additional referrals after that.
